## ORDINANCE NO. 39-15

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO DIRECTING THE DIRECTOR OF SAFETY AND SERVICE TO PURCHASE A SP-95 AERIAL PLATFORM FIRETRUCK FROM JEFFERSON TOWNSHIP, FRANKLIN COUNTY, OHIO FOR AN AMOUNT NOT TO EXCEED \$425,000.00 AND DECLARING AN EMERGENCY.

WHEREAS, the City of Jackson Fire Department has lost the use of the city ladder truck due to mechanical failure; and

WHEREAS, a ladder or platform truck of sufficient reach and height is required to protect the citizens and property in the City of Jackson and the lack of such a truck constitutes an emergency in the City; and

WHEREAS, the City has located a suitable used fire truck for sale by Jefferson Township in Franklin County, Ohio for the price of \$425,000.00; and

WHEREAS, the lack of a ladder or platform truck for the City of Jackson Fire Department constitutes a real and present emergency and immediately obtaining such a vehicle is necessary for the preservation of the health, safety and welfare of the City of Jackson and its residents and that, under the authority of R.C. 735.051, 735.052 or 735.053, the conditions obviate requirements of formal bidding.


NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

**Section 1.** The legislative authority of the City of Jackson hereby authorizes the Director of Service and Public Safety of the City of Jackson, Ohio to enter an agreement with for the purchase of the SP-95 Aerial Platform truck from Jefferson Township, Franklin County, Ohio for an amount not to exceed \$425,000.00 with \$100,000.00 to be paid from line item 333-7930-54002 and the balance to be paid from loan proceeds authorized by Ord. 38-15.

**Section 2.** This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
