ORDINANCE NO. 72-15 "Amended"

AN ORDINANCE REPEALING AND REVISING ORDINANCE 199-03 SO AS TO INCREASE THE COMPENSATION PAID TO THE CITY AUDITOR EFFECTIVE JANUARY 1, 2020.

WHEREAS, this legislative authority finds it beneficial to the City to repeal and amend Ord. 199-03 increasing the annual compensation paid to the City Auditor beginning January 1, 2020; and

WHEREAS, the City Auditor shall continue to be paid the same amount of annual compensation as being paid as of the date this Ordinance is adopted and the City Auditor shall continue to receive annual raises equal to increases received by City Supervisors and shall also be entitled to receive health insurance at the same rate as other City supervisors and all benefits provided by State law or City's policies until January 1, 2020; and


WHEREAS, effective January 1, 2020, and thereafter, the City Auditor shall receive an annual salary of \$50,000.00 together with health insurance at the same rate offered to other City supervisors and all benefits provided by State law and without other increase or decrease unless ordained by this legislative authority; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT ORDINANCE 199-03 IS HEREBY REPEALED AND AMENDED AND THE ANNUAL COMPENSATION AND BENEFITS PAID TO THE CITY AUDITOR SHALL BE AS FOLLOWS:

- A. The City Auditor shall continue to be paid the same amount of annual compensation as being paid as of the date this Ordinance is adopted ~~and the City Auditor shall continue to receive annual raises equal to increases received by City Supervisors~~ and shall also be entitled to receive health insurance at the same rate as other City supervisors and all benefits provided by State law or City's policies until January 1, 2020.
- B. Effective January 1, 2020, and thereafter, the City Auditor shall receive an annual salary of \$50,000.00 together with health insurance at the same rate offered to other City supervisors and all benefits provided by State law and without other increase or decrease unless ordained by this legislative authority.




