## **ORDINANCE NO. 01-17**

AN ORDINANCE AMENDING AND REPEALING ORD. 46-12 AND ESTABLISHING THE ANNUAL SALARY FOR THE SERVICE-SAFETY DIRECTOR OF THE CITY OF JACKSON TO BE \$67,800.

WHEREAS, this legislative authority finds it beneficial to the City to repeal and amend Ord. 46-12 and to increase the annual compensation paid to the Service-Safety Director to be \$67,800 annually; and

WHEREAS, the current salary for the position is \$61,800 plus the benefits of health insurance as provided to other City employees, life insurance as provided to other City employees, and dental/vision insurance as provided to other City employees. The Service-Safety Director shall not be entitled to overtime or comp time; and

WHEREAS, this authority sees fit to increase the current salary of the Service-Safety Director by \$6,000 per year, for an annual salary of \$67,800 plus all current benefits, to begin on the effective date of this Ordinance; and

WHEREAS, it is the intent of this legislative authority that, to the extent that this Ordinance is in conflict with any provision of another Ordinance, that the terms of this Ordinance be given effect in resolving the conflict.

NOW THEREFORE BE IT ORDAINED THAT THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO HEREBY INCREASES THE ANNUAL SALARY OF THE SERVICE-SAFETY DIRECTOR BY \$6,000 FOR A TOTAL ANNUAL SALARY OF CALL OF THIS ORDINANCE. IN ADDITION, THE SERVICE-SAFETY DIRECTOR SHALL CONTINUE TO RECEIVE THE BENEFITS OF HEALTH INSURANCE AS PROVIDED TO OTHER CITY EMPLOYEES, LIFE INSURANCE AS PROVIDED TO OTHER CITY EMPLOYEES, AND DENTAL/VISION INSURANCE AS PROVIDED TO OTHER CITY EMPLOYEES. THE SERVICE-SAFETY DIRECTOR SHALL NOT BE ENTITLED TO OVERTIME OR "COMP" TIME PAY.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this ordinance were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
