ORDINANCE NO. 40-17

AN ORDINANCE REPEALING AND AMENDING ORD. 41-99 SO AS TO REVISE SECTION 353.03 OF THE CITY OF JACKSON CODE OF ORDINANCES SO AS TO INCREASE THE TWO HOUR PARKING LIMITS TO FOUR HOURS AND TO PROHIBIT PARKING FOR MORE THAN 24 CONSECUTIVE HOURS ON CERTAIN PARTS OF MAIN, PEARL AND BROADWAY STREETS.

WHEREAS, Section 353.03 of the Codified Ordinances of the City of Jackson presently limits parking within certain areas of the City at two hours; and

WHEREAS, the legislative authority of the City of Jackson has determined it necessary to increase the parking limit in said areas to FOUR hours and to prohibit certain parking for more than 24 consecutive hours; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT SECTION 353.03 OF THE CODIFIED ORDINANCES OF THE CITY OF JACKSON BE AMENDED AS SET FORTH BELOW, WITH THOSE STRUCK THROUGH PORTIONS AND CAPITALIZED PORTIONS SHOWING THE AMENDMENTS TO THE ORIGINAL LANGUAGE AND THAT IT BE REPLACED WITHIN THE JACKSON CITY CODE, IN REGULAR TEXT.

353.03 ~~TWO~~FOUR-HOUR PARKING LIMIT.

~~(a) Within the area designated by the Safety/Service Director as a designated parking space for the public, no person may park for longer than two hours at a time in any designated parking space.~~

(b)(a) WITHIN THE AREAS DESIGNATED BY THE SAFETY/SERVICE DIRECTOR AS A DESIGNATED TIME RESTRICTED PARKING SPACE, THERE SHALL BE A ~~two~~ FOUR-hour PARKING restriction from 8:00a.m. to 4:00 5:00p.m. Monday through Saturday, except for holidays. The ~~two~~ FOUR-hour restriction shall not apply on Sundays, holidays, and time periods from 4:00 5:00p.m. to the following 8:00 a.m. SUBJECT TO 353.03(b), BELOW.

(b) IT SHALL BE PROHIBITED TO PARK FOR 24 OR MORE CONSECUTIVE HOURS ON THE FOLLOWING STREETS:

MAIN STREET BETWEEN PORTSMOUTH STREET AND CHURCH STREET;

PEARL STREET BETWEEN PORTSMOUTH STREET AND CHURCH STREET;

BROADWAY STREET BETWEEN PEARL STREET AND MAIN STREET.


