ORDINANCE NO. 65-18

AN ORDINANCE AMENDING AND REPEALING THE CODIFIED ORDINANCE SECTION 1501.01 AND ADOPTING THE 2017 OHIO STATE FIRE CODE AND DECLARING AN EMERGENCY.

WHEREAS, the City Codified Ordinance section 1501.01 has adopted the State of Ohio Fire Code then in effect from November 1, 2011 to the present; and

WHEREAS, upon recommendation of the Chief of the City of Jackson Fire Department, and pursuant to R.C. section 731.231, the City hereby amends and repeals its codified ordinance section 1501.01 and adopts the most recent edition of the Ohio Fire Code, as adopted by the Ohio Department of Commerce, Division of State Fire Marshal, published in Division 1301:7 of the Ohio Administrative Code; and

WHEREAS, the purpose of the Ohio Fire Code, as adopted herein, is to prescribe minimum standards and regulations governing conditions hazardous to life and property from fire or explosion and shall apply to the use of all lands and properties within the Municipality and such other lands or properties owned by the Municipality which are situated outside the corporate limits thereof.

NOW, THEREFORE, THE COUNCIL OF THE CITY OF JACKSON HEREBY ADOPTS, AS SET FORTH ABOVE, THE OHIO STATE FIRE CODE AS PUBLISHED IN DIVISION 1301:7 OF THE OHIO ADMINISTRATIVE CODE AND DECLARING AN EMERGENCY, AND DIRECTS THAT SECTION 1501.01 OF THE JACKSON CODIFIED ORDINANCES BE AMENDED TO READ AS FOLLOWS:

1501.01 ADOPTION.

There is hereby adopted by the Municipality, the 2017 Ohio Fire Code (OFC) as adopted by the Ohio Division of State Fire Marshal, Department of Commerce, and as published in Division 1301:7 of the Ohio Administrative Code (OAC).

In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this resolution were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, were in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
