ORDINANCE NO. 78-18

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, TO ENTER A CONTRACT FOR HEALTH INSURANCE COVERAGE WITH THE MICHIGAN CONFERENCE OF TEAMSTERS WELFARE FUND OF DETROIT MICHIGAN AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO, AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson, Ohio hereby finds that the current policy of insurance provided to the employees of the City as required by various collective bargaining agreements and contracts is due to expire and without said policy of insurance the City is in default with its employment agreements, and that the current provider of health insurance, the Michigan Conference of Teamsters Welfare Fund, 2700 Trumbull Ave., Detroit, Michigan, is willing to continue to provide health insurance coverage at competitive rates for City employees as follows:

Section 2. The Service Director is hereby authorized and directed to execute the contract for insurance according to the terms of the accepted proposal.

Section 3. This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio in order to maintain continuous insurance coverage as required by contract pursuant to the collective bargaining agreements and by other contracts with the City employees and competitive bidding requirements may thereby be obviated in accordance with Ohio law.





ORDINANCE NO. 79-18

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO ENTER INTO A CONTRACT FOR VISION, DENTAL AND LIFE INSURANCE COVERAGE WITH THE GUARDIAN LIFE INSURANCE CO., ADMINISTERED THROUGH PEOPLES INSURANCE, JACKSON, OHIO AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson, Ohio hereby finds that the current policy of dental, vision and life insurance provided to the employees of the City as required by various collective bargaining agreements and contracts is due to expire and without said policy of insurance the City is in default with its employment agreements, and that the current provider of vision, dental and life insurance, Guardian Life Insurance Co., 8800 Lyra Drive, Suite 690, Columbus, Ohio 43240, is willing to continue to provide vision insurance, dental insurance and life insurance coverage for City employees as follows:

GUARDIAN LIFE INSURANCE CO. – Vision Plan

GUARDIAN LIFE INSURANCE CO. – Dental Plan


The above policies of insurance shall be administered through Peoples Insurance, of Jackson, Ohio.

Section 2. The Service Director is hereby authorized and directed to execute the contract for vision, dental, and life insurance according to the terms of the proposal submitted by Guardian Life Insurance Co. and Peoples Insurance.

Section 3. This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio in order to maintain continuous insurance coverage as required by contract with the bargaining agreements and contracts with the City employees and competitive bidding requirements may thereby be obviated in accordance with Ohio law.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, where in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.


