ORDINANCE NO. 15-19

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO ACCEPT THE BID OF EATON-COOPER POWER FOR FOUR 15kV COOPER NOVA STS RECLOSERS WITH FORM 6 CONTROLS FOR THE SUBSTATION PROJECT FOR A COST NOT TO EXCEED \$79,208.00 AS IT WAS THE LOWEST AND BEST RESPONSIVE BID SUBMITTED AND DECLARING AN EMERGENCY.

WHEREAS, in response to a request for bids for the Substation Project for the City of Jackson, bids have been reviewed and a determination has been made as to the lowest and best responsive bid; and

WHEREAS, it has been determined that the lowest and best responsive bid was from Eaton-Cooper Power, 1319 Lincoln Ave., Waukasha, WI for 4 each, 15kV Cooper NOVA STS Reclosers with Form 6 Controls, in accordance with specifications priced at \$19,802.16 each for a total cost not to exceed \$79,208.00 to be paid from account #405-7555-54005; and

WHEREAS, the immediate passage of this ordinance constitutes an emergency as delay may cause an increase in price due and for the further reason that the immediate completion of the Substation Project will be beneficial to the operation of City services and is necessary for the preservation of the public's health, safety and welfare.

NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson hereby authorizes the Mayor or Director of Service and Public Safety of the City of Jackson, Ohio to accept the bid submitted and to award a contract to Eaton-Cooper Power for a cost not to exceed \$79,208.00 to be paid from account #405-7555-54005.

Section 2. This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio.

Section 3. In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.




