## ORDINANCE NO. 19-19

AN ORDINANCE OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO DIRECTING THE DIRECTOR OF SAFETY AND SERVICE TO ENTER INTO AN AGREEMENT FOR THE PURCHASE OF TWO 2020 PETERBILT 25 YARD GARBAGE TRUCKS FROM TLG FOR AN AMOUNT NOT TO EXCEED \$323,268.00 AND DECLARING AN EMERGENCY.

WHEREAS, the City is in need of acquiring a two garbage trucks after recent damage has been caused to two trucks leaving the City only a 2004 packer truck and recently leased truck; and

WHEREAS, the City had, prior to the loss of the second truck, requested bids for the purchase of a single truck and had received bids with delivery time for the completed truck to be between 2 and 5 months; and

WHEREAS, the City has an immediate need for the additional trucks and has negotiated the with a low bidder, TLG, the immediate use of a vehicle for \$1.00/month until the purchased trucks can be delivered, saving the City considerable expense from otherwise leasing a vehicle; and

WHEREAS, this matter constitutes a real and present emergency for the reason that adequate vehicles are required for the pick-up of trash in the City and doing so is necessary for the preservation of the health, safety and welfare of the City of Jackson and its residents and that, under the authority of R.C. 735.051, the conditions obviate requirements for formal bidding and advertising for contracts

## NOW, THEREFORE, BE IT ORDAINED AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson hereby authorizes the Director of Service and Public Safety of the City of Jackson, Ohio to enter an agreement with TLG, 2550 Annuity Drive, Cincinnati, Ohio 45241, to purchase two 2020 Peterbilt 25-yard garbage trucks at a cost of \$174,634.00 each for an amount not to exceed \$323,268.00 to be paid as follows: Line item #721-7540-54002 in the amount of \$259,000.00; and Line item #228-7625-54002 in the amount of \$64,268.00.

<u>Section 2.</u> This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio, for the reasons set forth herein.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
