ORDINANCE NO. 12-20

AN ORDINANCE REPEALING ORD 12-76, AS CODIFIED AT THE JACKSON CODE OF ORDINANCES SECTION 125.04, THAT ESTABLISHED A LIBRARY UTILITY CREDIT.

WHEREAS, the City of Jackson Ord. 12.-76 granted a \$200 monthly utility credit to the Jackson City Library for the City's use of the portion of the Memorial Building formerly used by the City Library; and

WHEREAS, the Jackson Library Board of Trustees have passed Resolution 14-2020 releasing any claim the Library Board may have to the use of the former library space and the monthly rental payment/credit, effective January 1, 2020, a copy of the resolution is attached hereto as Exhibit A; and


NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO, EFFECTIVE JANUARY 1, 2020, THAT ORD. 12-76 IS HEREBY REPEALED AND SECTION 125.04 OF THE CODIFIED ORDINANCES OF THE CITY IS REMOVED IN WHOLE AS FOLLOWS:

~~125.04 LIBRARY UTILITY CREDIT.~~

~~The City Library shall be granted a monthly credit for all water, sewer and electric charges assessed against the new City Library building not to exceed two hundred dollars (\$200.00) per month. The City shall be authorized to use that portion of the Jackson City Memorial Building formerly occupied by the library as consideration for such credit. (Ord. 12-76. Passed 3-22-76.)~~

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Ordinance were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including section 121.22 of the Ohio Revised Code.

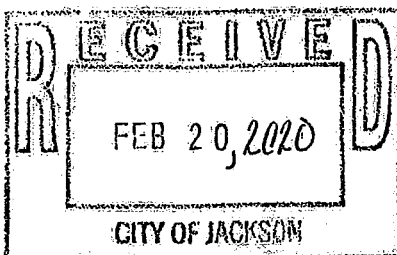
The Board of Trustees of the Jackson City Library met in regular session Tuesday, February 11, 2020 at 4:00 p.m. and adopted the following resolution:
