ORDINANCE NO.18-22

AN ORDINANCE REPEALING AND REVISING SECTION 957.01 OF THE CITY OF JACKSON CODE OF ORDINANCES SO AS TO MODIFY THE RATES AND RENTAL FEES FOR THE JACKSON MUNICIPAL POOL AND DECLARING AN EMERGENCY.

WHEREAS, Section 957.01 of the Codified Ordinances of the City of Jackson, as adopted by Ordinance 12-15, presently sets the rates and rentals at the Municipal Pool; and

WHEREAS, the legislative authority of the City of Jackson has determined that the current rates and rentals are insufficient in amount for the operation of the municipal pool and that the prior ordinance be repealed and amended with the *struck-through* portion omitted and the *underlined* language added so that the rates and rentals be increased as follows:

WHEREAS, this matter constitutes an emergency as immediate action to maintain the Jackson Municipal Pool and is necessary for the protection of the welfare, health and safety of the City.

957.07 RATES AND RENTALS

Admission rates and rentals for the Municipal Pool shall be as follows:

(a) General admission:

Open swim - regular admission	\$4.00
Open swim - Jackson City Schools student pass	2.00
Open swim – age 2 and under	<u>Free</u>

- (b) Season Tickets:
 - (1) Individual passes:
 - A. Regular season pass \$40.00 \$60.00
 - (2) Family passes:
 - A. Up to four members in same household \$120.00\$200.00
 - B. Same household, each additional member 10.00 \$30.00
- (c) Pool Party (City to provide concession and lifeguard):
 - (1) Two hours or less \$120.00\$175.00
 - (2) Each additional hour thereafter \$25.00
 - (3) If a group exceeds more than 50 persons, there shall be an additional charge 25.00 for every 25 additional persons

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT THE FOREGOING AMENDMENT GOVERNING RATES AND RENTALS AT THE MUNICIPAL

POOL BE REPLACED AS SECTION 957.01 WITHIN THE JACKSON CITY CODE, IN REGULAR TEXT.

This Ordinance is hereby declared to be an emergency Ordinance necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio as it is necessary to timely establish the rates and fees for the public at the time that the pool is opened for the season. Therefore, this Ordinance shall go into effect upon passage and approval by the Mayor as provided in Ohio Revised Code Section 731.30.

In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this ordinance were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
