ORDINANCE NO. 02-23

AN ORDINANCE REPEALING AND AMENDING THE CITY OF JACKSON'S CODIFIED ORDINANCE SECTION 179.01 ESTABLISHING THE MEMBERSHIP OF THE TREE COMMISSION.

WHEREAS, the legislative authority of the City of Jackson has published certain general and permanent ordinances in a volume of Codified Ordinances including section 179.01 that establishes membership of the Tree Commission; and

WHEREAS, the legislative authority of the City of Jackson has determined it necessary to revise section 179.01 so as to permit but not require the appointment of a non-resident of the City to the Tree Commission as a means to be able to consistently obtain qualified candidates for membership; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT SECTION 179.01 REGARDING THE MEMBERSHIP OF THE TREE COMMISSION AS SET FORTH BELOW, WITH THOSE STRUCK THROUGH PORTIONS BEING REMOVED AND REPLACED WITH THE UNDERLINED LANGUAGE SHOWING THE AMENDMENTS TO THE ORIGINAL LANGUAGE AND THAT IT BE REPLACED WITHIN THE JACKSON CITY CODE, IN REGULAR TEXT.

179.01 ESTABLISHED; MEMBERSHIP.

- (a) There is hereby established a Tree Commission for the City, which shall consist of the following five members: the Director of Public Service and Safety, a member of Council to be selected by Council, and three persons—citizens and residents of this City, at least two of whom shall be residents of the City and at least one of whom shall be of the opposite political party of the Mayor, who shall be appointed by the Mayor with the approval of Council.
- (b) The term of the three persons to be appointed by the Mayor shall be three years except that the term of two of the members appointed to the first commission shall be only one and two years respectively. In the event that a vacancy occurs during the term of any member, his successor shall be appointed for the unexpired portion of the term.
 - (c) Members of the Commission shall serve without compensation.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this ordinance were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were

in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
