RESOLUTION NO. 34-21

A RESOLUTION OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO AUTHORIZE THE SERVICE DIRECTOR TO ENTER AN AGREEMENT WITH G & J PAVING, INC., FOR ADDITIONAL STREET PAVING IN AN AMOUNT NOT TO EXCEED \$150,000.00 AS IT IS NOW FINISHING ITS CURRENT WORK ON THE 2021 CITY OF JACKSON STREET PAVING PROGRAM AND IS ON SITE WITH EMPLOYEES AND EQUIPMENT AND DECLARING AN EMERGENCY.

WHEREAS, in response to a request for bids for the 2021 Street Paving Program project, G & J PAVING, INC., submitted a bid that contained unit prices for work to be completed in furtherance of the City Street Paving project and its bid was found to be the lowest and best bid and was accepted by the City; and

WHEREAS, G&J Paving, Inc. is nearing completion of the paving for which it was contracted to complete and has informed the City that is able to offer additional paving at the same rates as contained in its original bid as its employees and equipment are on-site; and

WHEREAS, the City administration has identified additional paving projects that are needed within the City and desires to contract with G&J Paving, Inc. to complete additional paving at locations to be determined so as to not exceed \$150,000.00 to remain within the expenditure limit previously approved; and

WHEREAS, this matter constitutes a real and present emergency for the reason that immediate repair and repaving of City streets is required and necessary for the preservation of the health, safety and welfare of the City of Jackson and its residents and that the unit prices bid by G&J Paving, Inc. were the lowest and best bids for the current paving project and to require subsequent advertisement for bids will cause delay and expense and this opportunity is available for only such time that G&J Paving, Inc. has its employees and equipment on site in the City of Jackson so that, pursuant to the authority of R.C. 735.051, conditions obviate requirements for additional formal bidding and advertising for contracts

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The legislative authority of the City of Jackson hereby authorizes the Service Director to enter into an agreement with G & J Paving, Inc., of Chillicothe, Ohio, for an amount not to exceed \$150,000.00 for additional paving to be completed at the rates previously bid and to be paid from line item 234-7610-54004.

Section 2. For the reasons set forth herein, in order that the project may be completed immediately at the current rates, this Resolution is hereby declared to be an emergency Resolution necessary to maintain the public health, safety and welfare of the City. Therefore, this Resolution shall go into effect upon passage and as provided in Ohio Revised Code Section 731.30.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
