RESOLUTION NO. 10-22

**A RESOLUTION OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO ENTER INTO A CONTRACT FOR VISION, DENTAL AND LIFE INSURANCE COVERAGE WITH THE GUARDIAN LIFE INSURANCE CO., ADMINISTERED THROUGH PEOPLES INSURANCE, JACKSON, OHIO AND DECLARING AN EMERGENCY.**

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

**Section 1.** The legislative authority of the City of Jackson, Ohio hereby finds the lowest and best bidder for policies of dental, vision and life insurance provided to the employees of the City, as required by various collective bargaining agreements and contracts, to be Guardian Life Insurance Co., 8800 Lyra Drive, Suite 690, Columbus, Ohio 43240, to be administered through Peoples Insurance, of Jackson, Ohio, as set forth in Exhibit "A", attached hereto.

**Section 2.** The Mayor or his Service-Safety Director is hereby authorized and directed to execute the contract for vision, dental, and life insurance according to the terms of the proposal submitted by Guardian Life Insurance Co. and Peoples Insurance.

**Section 3.** This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio in order to maintain continuous insurance coverage as required by contract with the bargaining agreements.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, where in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
