ORDINANCE NO. 41-17

AN ORDINANCE REPEALING AND AMENDING ORD. 37-92 SO AS TO REVISE SECTION 353.99 OF THE CITY OF JACKSON CODE OF ORDINANCES SO AS TO MODIFY THE PENALTIES AND ABILITY TO REMOVAL OF VEHICLES FOR PARKING VIOLATIONS.

WHEREAS, Section 353.99 of the Codified Ordinances of the City of Jackson presently establishes the penalties for parking violations within the City; and

WHEREAS, the legislative authority of the City of Jackson has determined it necessary to increase the certain fines for parking violations and to permit removal vehicles parking in violation of City Ordinances; and

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON, OHIO THAT SECTION 353.99 OF THE CODIFIED ORDINANCES OF THE CITY OF JACKSON BE AMENDED AS SET FORTH BELOW, WITH THOSE STRUCK THROUGH PORTIONS AND CAPITALIZED PORTIONS SHOWING THE AMENDMENTS TO THE ORIGINAL LANGUAGE AND THAT IT BE REPLACED WITHIN THE JACKSON CITY CODE, IN REGULAR TEXT.

353.99 PENALTY.

(a) Penalties for parking violations shall be as follows:

- (1) ~~Fifteen dollar (\$15.00)~~ \$25.00 fine for parking in prohibited zone;
- (2) ~~Fifteen dollar (\$15.00)~~ \$25.00 fine for parking on yellow curb;
- (3) ~~Fifteen dollar (\$15.00)~~ \$25.00 fine for double parking;
- (4) ~~Fifteen dollar (\$15.00)~~ \$25.00 fine for parking over line;
- (5) ~~Twenty five dollar (\$25.00)~~ \$250.00 fine for parking in handicap zone;
- (6) ~~Fifteen dollar (\$15.00)~~ \$25.00 fine for parking beyond ~~two~~

DESIGNATED TIME limit.

(b) Parking violation penalties may be paid as provided on the parking ticket, form of which shall be approved by the Service-Safety Director.

(c) Whoever has accumulated a total of five parking tickets not paid within twenty-four hours after the time of issuance is guilty of a minor misdemeanor, and shall be fined not more than one hundred dollars (\$100.00). In addition, any motor vehicle owned or owned in part by such person and parking on any public street may be seized and towed to a place of safekeeping. Such motor vehicle shall be released to the owner only after the owner's unpaid parking tickets, all towing charges, and vehicle storage charges, are paid.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this ordinance were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
