**ORDINANCE NO. 39 -20**

**AN ORDINANCE MODIFYING APPROPRIATIONS IN VARIOUS FUNDS TO KEEP FROM EXCEEDING ESTIMATED REVENUE IN EACH AND TO MAINTAIN BUDGETARY COMPLIANCE AND DECLARING AN EMERGENCY.**

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF JACKSON, STATE OF OHIO, as follows:

**Section 1:** The prior appropriation regarding the following funds as set forth below is hereby modified as follows:

**Section 2.** This Ordinance is hereby declared to be an emergency Ordinance necessary to reduce earlier appropriations that are no longer necessary so that the budget does not exceed the estimated revenue for these funds. This is an emergency necessary to maintain the public health, safety and welfare so as to reduce the funds at the earliest date to be in budgetary compliance. Therefore, this Ordinance shall go into effect upon passage and as provided in Ohio Revised Code Section 731.30.


**Section 3.** In the event this Ordinance receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Ordinance shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council relating to the adoption of this Ordinance were adopted in an open meeting of this Council, and that the deliberations of this Council that resulted in such formal actions were in a meeting open to the public in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.


