RESOLUTION NO. 03-14

A RESOLUTION AUTHORIZING EXPENDITURE OF FUNDS FOR PAYMENT TO BRENTAG PURSUANT TO A "THEN AND NOW" CERTIFICATE IN THE AMOUNT OF \$5,959.80 AND DECLARING AN EMERGENCY.
