RESOLVED, That there be and is hereby levied on the tax duplicate of said City the rate of each tax necessary to be levied within and without the ten mill limitation as set forth in Schedule A and Schedule B, as attached hereto together with the Certificate To Copy to be completed by the Clerk of the Council of the City.

RESOLVED, that this matter constitutes an emergency as there is a deadline of September 30, 2014 by which the certification must be approved and the certification to the County Auditor of the tax levies is necessary for the preservation of the health, safety and welfare of the City.

It is hereby found and determined that all formal actions of this Council concerning and relating to adoption of this resolution were adopted in an open meeting of this Council and the deliberations of this Council and any of its committees that resulted in such formal action were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.
