WHEREAS, this matter constitutes an emergency necessary for the health, safety and welfare of the City that the contracts be approved so that operations of the various departments are uninterrupted.

NOW, THEREFORE, BE IT RESOLVED THAT THE LEGISLATIVE AUTHORITY OF THE POLITICAL SUBDIVISION OF THE CITY OF JACKSON THAT THE DIRECTOR OF PUBLIC SERVICE AND SAFETY IS HEREBY AUTHORIZED AND DIRECTED TO ENTER INTO THE EMPLOYMENT CONTRACTS ATTACHED HERETO TO FILL THE POSITIONS OF HEAD OF DEPARTMENT OF SERVICES, HEAD OF DEPARTMENT OF WATER, HEAD OF DEPARTMENT OF MECHANICAL SERVICES, HEAD OF DEPARTMENT OF WATER DISTRIBUTION AND WASTEWATER COLLECTIONS, HEAD OF DEPARTMENT OF WASTEWATER, AND HEAD OF DEPARTMENT OF UTILITY BILLING AND DECLARING AN EMERGENCY FOR THE REASONS SET FORTH HEREIN.

In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Resolution shall be deemed to have passed but with no emergency clause, and shall take effect at the earliest time permitted by law.
