RESOLUTION NO. 49-21

A RESOLUTION ACCEPTING FACT FINDING AWARD REGARDING THE NEGOTIATIONS BETWEEN THE CITY OF JACKSON, JACKSON COUNTY, OHIO AND TEAMSTERS LOCAL UNION 637, AFFILIATED WITH THE INTERNATIONAL BROTHERHOOD OF TEAMSTERS AND DECLARING AN EMERGENCY

WHEREAS, Ohio Revised Code Chapter 4117 establishes collective bargaining procedures for public employers and public employees; and

WHEREAS, pursuant to the provisions of Ohio Revised Code Chapter 4117, it is the desire of this Council that the Fact Finding Award issued in SERB Case Nos. 2021-MED-05-0794 (Dispatchers), 2021-MED-05-0794 (Patrol Officers), and 2021-MED-05-0796 (Sergeants) be accepted by the legislative body.

WHEREAS, This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health and safety of the City of Jackson as immediate action is required to meet the imposed deadlines for the City's response to the Fact Finding award. Therefore, this Ordinance shall go into effect upon passage and as provided in Ohio Revised Code Section 731.30.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Jackson, Ohio, that the Fact Finding Award issued in SERB Case Nos. 2021-MED-05-0794 (Dispatchers), 2021-MED-05-0794 (Patrol Officers), and 2021-MED-05-0796 (Sergeants) referenced above is hereby deemed accepted by the legislative body; and

BE IT FURTHER RESOLVED this matter constitutes an emergency for the reason set forth above and that the Council's authorized representative(s), are authorized to execute a collective bargaining agreement, in accordance with the terms of said award, on behalf of the Employer.
