## **RESOLUTION NO. 01-22**

A RESOLUTION AUTHORIZING THE DIRECTOR OF PUBLIC SERVICE AND SAFETY TO FILE AN APPLICATION WITH THE OHIO DEPARTMENT OF NATURAL RESOURCES FOR PADDLING ENHANCEMENT GRANT FINANCIAL ASSISTANCE FOR PUBLIC BOATING ACCESS AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio Department of Natural Resources ("ODNR") administers financial assistance for public boating access; and

WHEREAS, the City of Jackson desires financial reimbursement under ODNR's Paddling Enhancement Grant Program; and

WHEREAS, this matter constitutes an emergency necessary to protect the health, safety and welfare of the City as a timely or early application will increase the opportunity for the City to receive the grant requested; and

**NOW THEREFORE** be it Resolved by the legislative authority of the City of Jackson as follows:

<u>Section One.</u> The City of Jackson approves of filing an application for Paddling Enhancement Grant financial assistance.

<u>Section Two.</u> The Director of Public Service and Safety is hereby authorized and directed to file and execute an application with ODNR and provide all information and documentation required to be eligible for possible financial assistance.

<u>Section Three.</u> The legislative authority of the City of Jackson agrees that it has and will obligate the funds required to satisfactorily complete the project under the term and conditions of the Cooperative Agreement if the project is accepted for financial assistance.

<u>Section Four.</u> This Resolution is hereby declared to be an emergency Resolution, necessary to protect the health, safety and welfare of the City of Jackson for the reasons set forth above. Therefore, this Resolution shall go into effect upon passage and approval by the Mayor as provided in Ohio Revised Code Section 731.30.

In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Resolution shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that the

deliberations of this Council that resulted in such formal actions were in a meeting open to the public, in compliance with all legal requirements, including Section 121.22. of the Ohio Revised Code.
