RESOLUTION NO. 11-22

A RESOLUTION OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO ENTER INTO A CONTRACT FOR HEALTH INSURANCE COVERAGE WITH THE MICHIGAN CONFERENCE OF TEAMSTERS WELFARE FUND OF DETROIT MICHIGAN AND DECLARING AN EMERGENCY.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>Section 1.</u> The legislative authority of the City of Jackson, Ohio hereby finds the lowest and best bidder for a policy of health insurance provided to the employees of the City, as required by various collective bargaining agreements and contracts, to be the Michigan Conference of Teamsters Welfare Fund of Detroit Michigan, as set forth in Exhibit "A", attached hereto.

<u>Section 2.</u> The Mayor or his Service-Safety Director is hereby authorized and directed to execute the contract for health insurance according to the terms of the proposal submitted by Michigan Conference of Teamsters Welfare Fund of Detroit Michigan.

<u>Section 3.</u> This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio to maintain continuous insurance coverage as required by contract with the bargaining agreements.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, where in meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
