NOW, THEREFORE, BE IT RESOLVED by the City Council of Jackson, Ohio, that the Fact Finding Award issued in SERB Case No. 2021-MED-06-0773 referenced above is hereby deemed accepted by the legislative body; and

BE IT FURTHER RESOLVED that this matter constitutes an emergency for the reason set forth above and that the Council's authorized representative(s), are authorized to execute a collective bargaining agreement, in accordance with the terms of said award, on behalf of the Employer.
