RESOLUTION NO. 54-23

A RESOLUTION OF THE LEGISLATIVE AUTHORITY OF THE CITY OF JACKSON, OHIO TO DESIGNATE THE CITY OF JACKSON COMMUNITY IMPROVEMENT CORPORATION AS THE AGENCY FOR THE CITY FOR THE INDUSTRIAL, COMMERCIAL, DISTRIBUTION, AND RESEARCH DEVELOPMENT IN THE CITY AND DECLARING AN EMERGENCY.

WHEREAS, the City of Jackson Community Improvement Corporation is an Ohio non-profit corporation established pursuant to Ohio Revised Code chapter 1724 for the purpose of advancing, encouraging, and promoting the industrial, economic, commercial, and civic development of the City of Jackson, Ohio, by facilitating the reclamation, rehabilitation, and reutilization of real property within the City and holding such real property pending its reclamation, rehabilitation, or reutilization; and

WHEREAS, the City is permitted pursuant to RC section 1724.10 to designate The City of Jackson Community Improvement Corporation as the agency of the City for the industrial, commercial, distribution and research development within the City; and

WHEREAS, this matter constitutes an emergency which is necessary for the preservation of the public's health, safety and welfare as there is a deadline for the corporation to apply for grant funding which is essential for the fulfilment of the purposes set forth above.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

<u>Section 1.</u> The legislative authority of the City of Jackson hereby designates The City of Jackson Community Improvement Corporation as the agency of the City for industrial, commercial, distribution and research development within the City and authorizes the Mayor to enter into an agreement necessary to give this Resolution effect.

<u>Section 2.</u> This matter is hereby declared to be an emergency necessary for the immediate preservation of the public peace, health or safety of the City of Jackson, Ohio, for the reasons set forth herein, in order to maintain the safety of the City and its residents.

<u>Section 3.</u> In the event this Resolution receives a majority vote for passage but fails to receive the required number of votes to pass as an emergency, then this Resolution shall be deemed to have passed but with no emergency clause and shall take effect at the earliest time permitted by law.

It is hereby found and determined that all formal acts of this council concerning and relating to adoption of this Resolution were adopted in an open meeting of this council and that the deliberations of the council and any of its committees resulted in such formal action, wherein meeting open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.
